MEMORANDUM of UNDERSTANDING

This Memorandum of Understanding is in between Kendrapara Autonomous College, Kajala, Tinimuhani, Kendrapara-754211 (Odisha), India and Srusti Academy of Management (Autonomous) (referred to as Srusti), 38/1, Chandaka Industrial Estate, Near Infocity, Bhubaneswar-751024, Odisha, India hereinafter referred to as Kendrapara Autonomous College and Srusti.

Article One

Kendrapara Autonomous College and Srusti shall endeavor to promote educational, research, entrepreneurship development and social outreach cooperation activities (between the Kendrapara Autonomous College and Srusti) on the basis of mutual respect for each other's autonomy, in conformity with the laws and regulations in force in each institution, and within their respective available resources.

Article Two

Kendrapara Autonomous College and Srusti shall endeavor to exercise their best efforts to develop exchange agreements that will further define specific joint activities.

Article Three

Kendrapara Autonomous College and Srusti shall endeavor to exercise their best efforts to develop the following forms of cooperation through **online** or physical visit method.

1. Conduct of faculty development programme, staff development programme, seminars, conferences, workshops and consulting work in joint collaboration.
2. Development of collaborative research programmes and joint publications.
3. Conduct of need-based student development activities including career counseling and employability Skill development training in joint consultation and mutually agreed, condition.
4. Conduct collaborative entrepreneurship development.
5. Conduct social outreach activities.

Article Four

This Memorandum of Understanding becomes effective on the date of its signing by the authorized representatives of both the institutions. It shall be effective for five years and reviewed prior to renewal. This Memorandum of Understanding may be terminated by either party upon six months written notice to the other party.

This Memorandum of Understanding is written in english in two (2) copies. As witness to their consent to this Memorandum of Understanding, the appropriate authorities hereunto provide their signatures.

Memorandum of Understanding

This Memorandum of Understanding is executed at Cuttack
(hereinafter the "MOU")
on this day of 3rd March 2022;

By and Between

Sri Sri University, Ward No 3, Sandhapur, Godiahi, Cuttack, Odisha-754006, (hereinafter referred to as SSU) a State Private University established by Sri Sri University Act- 2009 by Odisha State Legislative Assembly, has been founded by His Holiness Gurudev Sri Sri Ravi Shankar a global humanitarian and thought leader in Yoga and meditation. The University- a Pioneer academic institute in India offered value-based education that combines Western innovations with the ancient values and wisdom of the East. Sri Sri University offers education in the field of Management, Yogic Science, Science, Governance, Agriculture, Architecture, Doctoral Studies and has championed bringing in creative innovation through research and field practices. SSU aims to Learn, Lead and Serve through holistic education for the national and international students in smoke-free, drug-free, and alcohol-free campuses from 2012. Sri Sri University is recognized by UGC, AICTE, Ministry of HRD, Government of India, and Government of Odisha, represented by **Officiating Executive Registrar, Prof. (Dr.) D. P. Sahoo**, which expression shall, unless repugnant to the meaning or context thereof, be deemed to include its/their successors, heirs, and administrators), of the **First Part**;

AND

Kendrapara Autonomous College hereinafter referred to as KAC and having its registered office at Kendrapara, Odisha represented through its **Principal, Dr. Rajendra Prasad Tripathy** which expression shall, unless repugnant to the context or meaning thereof, mean and include its successors, be deemed to include its successors and administrators of the **Second Part**;

1. Whereas:

SSU and KAC are interested in entering into an MoU with a view of sharing a common desire to explore extend and strengthen the mutual relationship with well-established academic and Research & Development set up to share the facilities and expertise available with each of them, herewith sign this MoU on the Understanding stated in the subsequent paragraphs.

2. Faculty Exchange:

The Faculty members of SSU and KAC shall take part in relevant exchanges of teaching and training of their respective curriculums. In-person and online lectures shall be arranged as per the predefined schedule by both the Institutions.

3. Student Exchange:

- (a) Student exchange program will be envisaged with a vision to enable students to learn the philosophy and practice of both organizations.
- (b) Selected groups of students from both institutes would be sent to each other, wherein academic activities of a certain duration would be organized.
- (c) Both the institutes shall make similar lodging & boarding arrangements for students of each other.
- (d) Travel costs will be borne by the parent institute.
- (e) Collaborative Research and Publications:
 - i. The Faculty/ Researchers of SSU and KAC may work on joint collaborative research projects in areas of mutual interest and may apply for the fund to National and International Funding Agencies. Research Data acquired in such collaborative research will be published jointly in peer-reviewed journals by name of both Institutions.
 - ii. Both the Institutions shall jointly organize seminars as and when required in significant areas of exploration.

(f) Admissions & Promotion:

- i. Both Parties agree that their respective Institution will share information and utilize the resources of the other Institution for admission & Promotion. The campus and the premises of both institutions will be utilized by each other for conducting counselling/ interview/ entrance tests on mutual consent. However, any administrative help and support services required for conducting such interviews will be made available by the other Institution and the actual cost and expenses for the same to be charged.

- ii. Both the Parties hereby agree that they will jointly conduct promotional events about the promotion of their respective Institutions, as may be mutually agreed. The expenses to be incurred wrt to organizing and conducting the aforesaid promotional events, advertisement, venue, administrative expenses, will be borne by the parties as may be mutually agreed on a case to case basis.
- iii. Both the Parties agree that they will jointly conduct promotional events in such parts of the world, about the promotion of their respective Institutions to attract international students to their respective Institutions, as may be mutually agreed between the Parties. It is hereby clarified that any costs and expenses incurred to organizing and conducting the aforesaid promotional events, including the cost of advertisement, venue, administrative expenses, will be borne by the Parties as may be mutually agreed on a case to case basis.

(g) Recruitment:

Both the institutions agree to give preference to the students of each Institution who have applied for any relevant vacant positions in either Institution under regulations and statutory guidelines. This will further create more avenues of a stronger bond between the institutions as the philosophical learning and understandings will be existent mutually in the form of employed students.

- (h) Both the Parties seek to enhance relations and recognize the benefits to be derived from increased collaboration, cooperation, and interaction for further promotion.
- (i) On behalf of **First Party Prof. (Dr.) Sunil Dhal**, Professor, FMS will be the point of contact for further correspondence.
- (j) On behalf of the **Second Party Dr. Suresh Chandra Das** will be the point of contact for further correspondence.
- (k) This Memorandum of Understanding shall enter into force based on goodwill and shall not be legally bound.

4. Termination:

The MoU is valid for **five years** from the date of signature (03.03.2022) by both the parties and may be renewed for any other period as shall be agreed on in between the parties. If either Party does not wish to continue this MoU, then such Party provide the other Party with its intention to terminate this MoU, by giving **3 (three) months'** notice in writing.

5. Notice:

Any notice or other communication hereunder shall be in writing, shall be sent via registered post and E-mail, and shall be deemed given when deposited, postage prepaid, in the mail, to the addresses of the Parties as stated above or to such address as either of the Parties shall advise the other in writing.

6. Arbitration:

This MoU shall be legally binding on both the Parties. If any dispute or difference of any kind whatsoever shall arise between the parties in connection with the present MOU, parties shall promptly refer the dispute or difference to arbitration and an arbitrator shall be appointed by both the parties under the provisions of the Arbitration and Conciliation Act, 1996 or its amendment thereof as being in force from time to time. Any dispute proceedings arising out of this MoU shall be subject to the laws of India, specifically within the jurisdictional court/tribunal/judicial authorities of Cuttack. The award of the Arbitrators shall be final and binding on both parties.

7. Governing Law:

This MOU shall be construed, interpreted and applied under, and shall be governed by, the laws applicable in India. The Courts/tribunal/judicial authorities at Cuttack shall have the exclusive jurisdiction to entertain any dispute or suit arising out of or concerning this MOU.

MEMORANDUM OF UNDERSTANDING BETWEEN TULASI WOMEN'S COLLEGE, KENDRAPARA AND KENDRAPARA AUTONOMOUS COLLEGE, KENDRAPARA

The Memorandum of Understanding (here in after referred to as MOU) is being entered into on this 9th March, 2022

By and Between

Tulasi Women's College having its registered office at Kendrapara-754211, Odisha of First Party AND Kendrapara Autonomous College, Kendrapara is referred as second party

1. OBJECTIVES:

The MOU relates to proposed links between the college and the Institutions. The parties propose to cooperate in discussions and joint activities in relation to the following.

Exchange of academic activities, which provide the opportunities for the institution and the college, carry out joint projects and joint patent.

Responsibility of 1st Party:

- To undertake harmony in society.
- Facilitates the exchange of staffs, students and researchers for the purpose of teaching, study and academic research.
- Provides the laboratory academic and research facilities.
- Provides administrative support for growth of academic in association with the college.
- Provides bilateral advice and support to the collaborative institution for growth of its academic and administration.

Responsibility of 2nd Party:

- Identification of areas of possible mutual academic interest.
- Identification of potential research opportunities and initiative.
- The dissemination of information and the sharing of experiences among staffs and students.

2. PERIOD:

This MOU is effective from the date of signature by both parties for a period of two calendar years. It can be extended on mutual agreement of the both the parties.

3. DISPUTE RESOLUTION:

If either party has any issues, concerns or complaints about any matter arising out of or in connection with this MOU. That party shall notify the other party and the parties shall then seek to resolve within a reasonable period of time, the matter shall be escalated to the Principal on behalf of Kendrapara Autonomous College, Kendrapara.



4. CHARGES AND LIABILITY:

The parties shall each bear their own costs and expenses incurred in complying with their obligation under this MOU.

5. STATUS:

This MOU is not intended to be legally binding (Except in relation to paragraph 4), and not legal obligations or legal rights shall arise between the parties from this MOU. The parties enter into this MOU intending to honour all their obligations.


