

# MEMORANDUM of UNDERSTANDING

# Article One

## **Article Three**

- Conduct of faculty development programme, staff development programme, seminars, conferences, workshops and consulting work in joint collaboration.
- 2. Development of collaborative research programmes and joint publications.
- Conduct of need-based student development activities including career counseling and employability Skill development training in joint consultation and mutually agreed, condition.
- Conduct collaborative entrepreneurship development.
- Conduct social outreach activities.

## Article Four

This Memorandum of Understanding becomes effective on the date of its signing by the authorized representatives of both the institutions. It shall be effective for five years and reviewed prior to renewal. This Memorandum of Understanding may be terminated by either party upon six months written notice to the other party.
